Community Organizations We provide free legal services to nonprofits and microenterprises.

Nonprofits Wayfind supports nonprofits so they can focus on their missions. We connect nonprofits with volunteer attorneys who help them with their business-related legal needs. We do not provide support with litigation or dispute-related issues.

Eligibility

To be eligible for free legal assistance through Wayfind, an organization must show that it:

- Has a primarily charitable or community-based purpose;
- Is or seeks to become a 501c3 or 501c4 non-profit organization;
- Is unable to pay for legal fees without significant impairment of program resources; and
- Seeks legal assistance on business or organizational matters.

Start-up organizations are eligible for legal assistance provided they satisfy the above-listed criteria, demonstrate potential viability, and submit a business plan and budget.

Attorneys We help lawyers do good.

Wayfind provides business pro bono opportunities to Washington attorneys so they can efficiently share their expertise with nonprofits, enabling the nonprofits to focus on their missions. Wayfind screens all nonprofit requests for services to ensure the organization is viable and has a ripe business legal need.

We provide malpractice insurance coverage for our volunteers on Wayfind matters.

Get Involved

Interested in getting involved? There are two ways to volunteer:

- 1. Help a nonprofit or community organization with business-related or organizational (non-litigation) legal needs.
- 2. Staff one of our Microenterprise Legal Clinics. You can consult with microenterprises at one of our three legal clinics. Volunteer once, or as many times as you want.
