You can also receive a prepackaged box of food with: soup, pasta, peanut butter, rice, canned fruits and vegetables, beans, tuna, and cereal. During each visit, you will be able to pick up enough food for at least 21 meals. You do not need to call in advance

11. Bellevue College: Bellevue College Workforce Education is currently accepting applications for their spring quarter that begins April 2nd. Learn more and apply here! Workforce Education provides services to low-income or unemployed people to help them achieve their academic and career goals. They provide funding for tuition, fees, and potentially other costs like books and transportation for eligible students in <u>approved programs of study</u>.

12. Solid Ground: Working Families Tax Credit Information You can now get your Working Families Tax Credit as a prepaid debit card, which means you don't need a bank account to get your refund. You will also have access to your money right away and can use your card to make purchases, pay bills, or get cash. You can still get your refund as a direct deposit or a paper check as well. Under the Working Families Tax Credit, Washington state individuals and families may receive up to \$1,255 back if they meet certain eligibility requirements. If you didn't get your refund last year, there's still time to apply. TO APPLY: Working Families Tax Credit – Prepaid debit cards MORE INFO: Go to Working Families Tax Credit – Apply

13. **HCA Lifeline Phone Services** Lifeline is the Federal Communications Commission's program to make communications services accessible to low-income consumers in Washington State. Lifeline provides subscribers a discount on monthly telephone service, broadband Internet access service, or voice-broadband bundled service purchased from participating providers.

14. **WA State Dept of Health: Free Covid Tests for Those with Visual Impairment** Free at-home COVID-19 tests are available for people who are blind or have low vision. Ellume's COVID-19 test technology provides audible step-by-step instructions and test results, making it more accessible.
